


2026 RULES

General Rules

- Children 11 years and under must be under the direct supervision of a related adult (18+). Direct supervision means being within arm's reach.
- No food, drink, gum, coolers, or glass are allowed in the pool area. (Bags are subject to inspection.)
- Glass is strictly prohibited. If broken, parts of the pool may close for cleanup.
- No lawn chairs, tents, or outside furniture are allowed.
- Lounge chairs must remain in their designated spots and may not be moved.
- Smoking, vaping, drugs, or alcohol are not allowed on the premises.
- Patrons may not bring personal speakers or play their own music.
- No pool toys (balls, frisbees, water guns, rafts, floaties, noodles, etc.).
- Only U.S. Coast Guard-approved life jackets are permitted as flotation devices.
 - o The image below highlights the features of a U.S. Coast Guard-approved lifejacket:



- Shower with soap and rinse before entering the pool.
- Proper swim attire is required. No jeans, cutoffs, or street clothes.
- Guests with unapproved casts, open wounds, rashes, or infectious conditions are not allowed in the
- No roughhousing, fighting, horseplay, or running.
- Diving is only permitted off diving boards.
- Spitting, spouting water, or nose-blowing in the pool is prohibited.
- Do not hang on or climb railings, lane ropes, or dividers.
- Adults must stay within arm's reach of children wearing flotation devices.
- Adults must be in the water and actively supervising children ages 7 and under.

• Coolers are allowed only with Party Pavilion rentals and must be removed once the rental ends.

Safety & Operations

- Inappropriate or unsafe behavior (including foul language or disrespect toward staff/guests) may result in suspension of privileges up to six (6) months.
- Lazy River tubes must remain in the Lazy River area.
- The Rush may close due to inadequate staffing, unsafe pool chemistry, inclement weather, or low attendance. Updates will be posted on our official Facebook page.
- Facility rentals are only available on Saturdays 9:30–11:30 AM and Sundays 6:30–8:30 PM. Swimming and safety rules apply at all times. Unsafe behavior may result in the rental ending without refund.
- In the event of a lost child or emergency, paging and temporary facility lockdown procedures may be used until the child is found.
- For swimmers to enter the pool, the combined water and air temperature must equal at least 130°F.
- Season passes are non-transferable and may not be shared. The pass holder's name must match the person entering. Misuse may result in revocation.
- In the event of a fecal or vomit incident, pool closures will follow CDC guidelines. Guests in attendance for less than two hours may be eligible for a Splash Pass, at management's discretion.
- The City of Republic is not responsible for lost, stolen, or damaged items.
- Please obey and respect all staff. Failure to do so may result in loss of privileges.
- Pool management may enforce additional rules as needed to protect guest safety.

Cancellation, Refund & Weather Policies

- Rentals must be reserved by someone 18 or older.
 - o Facility rentals: cancellations must be made 7 days in advance for a full refund.
 - Cabana/Terrace rentals: cancellations must be made 48 hours in advance for a full refund. Later cancellations receive 50%.
- If rentals are canceled due to weather, renters may receive a full refund or reschedule.
- The pool will clear for lightning, heavy rain, or threatening weather.
 - Reassessed every 30 minutes for up to 1 hour.
 - If threatening weather persists past 1 hour, the pool may close for the day.
 - Rain checks issued only if closure occurs and guests have been present for less than 2 hours.
- If the pool does not open by 3:00 PM due to weather, it will remain closed for the day.
- The Rush may restrict entry when occupancy is full.
- All rentals (party packages, cabanas, terraces) must be paid in full at reservation.
- No cash refunds. Refunds for cash payments will be issued as Splash Passes; card payments refunded back to the card.

Attraction-Specific Rules

Lazy River

- Do not hang on walls.
- One person per tube. Small children may sit on an adult's lap (life vests recommended).
- Keep head above the tube. No standing, kneeling, or jumping on tubes.
- No diving.
- Enter/exit only at designated areas.

Diving Boards

- One person on the board at a time; one bounce only.
- No throwing objects.
- No flotation devices, goggles, hats, or glasses.
- Jump straight forward only; no flips/backflips.
- Wait for the previous jumper to clear before climbing/jumping.
- Non-swimmers not allowed in diving area.
- No catching jumpers.
- Use designated exits only.
- · Lifeguards may stop unsafe activity.

Waterslides

- Riders must be at least 48" tall and under 300 lbs.
- Ride lying on back, arms and legs crossed. No sitting up, running, standing, or stopping.
- Enter seated, wait for lifeguard instruction.
- No jewelry, clothing with zippers, or cutoff jeans. Swimsuits only.
- One rider at a time. No tubes, mats, or life jackets.
- Riders must be in good health. Pregnant guests or those with heart/back issues should not ride.
- No alcohol/drug influence.
- Exit the plunge pool promptly.
- No catching riders at the bottom.

The Huna (FlowRider)

- This is a strenuous ride with turbulent water.
- Riders must be at least 42" tall (measured against height marker).
- Jewelry, glasses, shoes, and loose clothing are not recommended.
- Bathing suits may shift or come off in strong water; secure clothing is suggested.
- Ride instructions must be followed (bodyboard vs. flowboard).
- Enter only when instructed by lifeguard.
- No tandem/multi-person riding.
- Do not walk on the ride surface; exit only after a complete stop.
- If The Huna closes for maintenance, guests using it for less than 2 hours may receive a Splash Pass (1 Huna Band), at management's discretion.
- Personal boards require supervisor approval; The Rush is not responsible for personal equipment.
- Always obey the lifeguard.

^{*}The height requirements for the slides and Huna were established by the manufacturer, and The Rush-Republic Aquatic Park is unable to alter these specifications as they are not the manufacturer.

The Rush Dress Code Policy

At The Rush, we are committed to providing a family-friendly environment that prioritizes the safety and comfort of both our guests and team members. To ensure a safe and enjoyable experience, and prevent avoidable damage to the premises, all guests are expected to adhere to the rider safety rules and requirements posted throughout the premises as well as the following dress code:

- 1. Swimwear or other apparel with buckles, protruding metal, or any other sharp material or objects (e.g., buttons, zippers, rivets, studs, etc.) is prohibited.
- 2. Swimwear or other apparel made from corduroy or denim fabric/material are prohibited from being worn in the pools, lazy river or on any slides or attractions (such as the wave rider or the diving boards). Guests who will not be entering the water (including use of the diving boards, slides, lazy river and wave rider) may wear corduroy or denim otherwise on the premises.
- 3. Cotton shirts (e.g., t-shirts) may not be worn on any slide where the rider's upper body comes into direct contact with the slide. (Swim shirts, such as rash guards, are permitted to be worn on the slides, but must be tight-fitting in order to ensure rider safety).
- 4. Religious headwear or apparel is permitted to be worn, but must be tight-fitting/securely attached to the rider's person in order to ensure the safety of both the rider and nearby patrons.
- 5. Guests may be asked to remove any body piercing that may come into direct contact with the slide before being permitted to ride.
- 6. Clothing or swimwear with words, images, or symbols showing sexual acts, extreme violence, or vulgar language that is clearly unsuitable for a family-friendly place is prohibited from being worn on the premises.
- 7. Clothing or swimwear bearing words or images promoting violence or otherwise intended to incite violence are prohibited from being worn on the premises.
- 8. Clothing or swimwear that fails to provide adequate coverage of the chest, buttocks, and genital areas, or that becomes transparent when wet, is not permitted.

Guests who are not in compliance with the dress code requirements may be asked by personnel to make necessary adjustments in order to comply with the requirements. Guests who refuse to follow any such request (but persist in violating the dress code) will be asked to leave the premises. Guests who fail or refuse to comply with the rider safety rules posted throughout the premises may additionally be subject to dismissal from the property, with or without advance warning.

Buying a season pass, purchasing daily admission, Huna band, party package, or facility rental means you understand and agree to ALL the following rules above.
